OFFICIAL RULES

NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: The Cointreau Movie Night Sweepstakes ("Sweepstakes") begins at 12:00:00 AM Pacific Time ("PT") on January 1, 2021 and ends at 11:59:59 PM PT on March 31, 2021 ("Sweepstakes Period"). The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participants ("Participants") agree to be bound by these Official Rules and the decisions of Remy Cointreau USA, (the "Sponsor"), which are binding and final on matters relating to this Sweepstakes.

ELIGIBILITY: Sweepstakes is open only to legal residents of the fifty (50) United States or the District of Columbia (NOT including residents of Puerto Rico or other U.S. Territories), who are at least 21 years of age or older at the time of Sweepstakes Entry. 2) Mail-in Entry: To receive one (1) entry in the Sweepstakes without visiting the Website (“Mail-In Entry”), hand print your name, complete address (no P.O. boxes permitted), phone number (including area code), date of birth and email address on a 3” x 5” piece of paper and mail in an envelope with proper first class postage affixed to: Cointreau Movie Night Sweepstakes, PO Box 90130, Nashville, TN 37209.
